RENTAL POLICY TERMS

FIRST DAY OF RENTAL BEGINS 4 BUSINESS DAYS AFTER SHIPPING

(If you have not received your saddle within this timeframe, contact us so we may check shipment tracking).

LESSEE AGREES TO BE CHARGED **\$300** PER MONTH UNTIL SADDLE HAS BEEN PAID IN FULL, OR OTHERWISE RETURNED TO SPORTS SADDLE, INC.

Lessee may pay up-front for one or more months. Normal month to month basis will be **\$300 per month**. With first month payment, the lessee will also be charged a **deposit of \$60**. If lessee decides to return the leased saddle, the deposit of \$60.00 will be refunded to the lessee. If the lessee keeps the saddle until paid, the **deposit fee will go toward the cost of the saddle**. Shipping from Sports Saddle to lessee (within contiguous USA) is a non-refundable flat rate of **\$70**. Shipping fee does not go toward the cost of the saddle. If saddle is returned, lessee is responsible for payment of return shipping costs. Discounts may be offered if lessee has rented before and has maintained good status (such as returning saddle in good condition and making payments on time). Payments must be made through the lessee's own debit or credit card. If saddle is returned in extraordinary conditions (broken or very much worn down) there will be a charge to the lessee's account to cover repair costs of getting saddle back to a condition deemed fit for resell.

ANY AND ALL SADDLES RENTED BY LESSEE MUST COME BACK CLEAN AND IN GOOD CONDITION.

Within the first 30 days, Lessee will have the option to trade saddle for another lease saddle if first saddle comes back in good condition (Lessee will be responsible to pay shipping costs for both saddles). Decision for lease saddle trade requests beyond 30 days will be left to the discretion of Sports Saddle, Inc.

Lessee will have the option at any time to buy out the saddle they have rented (Monthly rental fees paid to-date as well as the deposit fee will be deducted from the final price of the saddle).
